AGREEMENT

This Agreement is entered into on this the 31st day of July, 2024, by and between Madison County, Alabama (hereinafter "Madison County") and the City of Huntsville, Alabama, a municipality (hereinafter the "City").

RECITALS

A. The City is a municipality which has a lawful public purpose benefiting the general public and is not engaged in private enterprise.

B. Madison County desires to enter into this Agreement with the City as part of a collaborative effort to promote cultural and educational activities in the form of music concerts.

NOW, THEREFORE, in consideration of the above recitals, the obligations and the payments to be made hereunder, it is agreed by and between the parties as follows:

1. Madison County shall pay to the City the sum of \$2,500 from the Madison County District 6 budget. These funds shall be used to assist with Jazz in the Park Summer Concert Series. These funds shall not be used for other than a lawful public purpose.
