## **RESOLUTION NO. 25-\_\_\_\_**

**BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, that Resolution No. 25-477, adopted and approved on June 12, 2025, is hereby rescinded; and

**BE IT FURTHER RESOLVED** by the City Council of the City of Huntsville, Alabama, that the Mayor be, and he is hereby authorized to enter into an Agreement by and between the City of Huntsville and Madison County, Alabama, for the repaving of Old Big Cove Road from Sutton Road to Taylor Road, on behalf of the City of Huntsville, a municipal corporation in the State of Alabama, which said agreement is substantially in words and figures similar to that certain document attached hereto and identified as an "Agreement by and between the City of Huntsville and Madison County, Alabama," consisting of one page, and the date of July 24, 2025, appearing on the margin of the first page, together with the signature of the President or President Pro Tem of the City Council, an executed copy of said document being permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama; and

## **AGREEMENT**

This Agreement (the "Agreement") is made and entered into by and between the City of Huntsville, an Alabama municipal corporation (the "City") and Madison County, Alabama, a political subdivision of the State of Alabama (the "County"). This Agreement is effective as of the 18<sup>th</sup> day of June, 2025.

WHEREAS, the County has resurfaced three sections of roadway (hereinafter collectively referred to as the "Project"); and

WHEREAS, the Project consisted of the paving the following: Old Big Cove Road from Sutton Road to Taylor Road;

WHEREAS, the City and the County have a mutual interest in the Project; and

WHEREAS, the City will contribute financially to the Project.

NOW THEREFORE, the City and the County mutually desire to set forth their understanding and agreement as set forth herein:

- 1) The County has completed the Project and was responsible for the design and construction of the paving and other improvements. The County has notified the City and the City has accepted improvements within the city limits. The County will provide the City with a one (1) year warranty for all improvements made within the city limits.
- 2) All working materials necessary for said construction were procured in accordance with the Alabama Competitive Bid laws.
- 3) The City will contribute ONE HUNDRED THREE THOUSAND, TWO HUNDRED FIFTY DOLLARS AND 47/100 (\$103,250.47) towards the Project in the form of one lump sum payment to the County to be paid within thirty (30) days from the full execution of this Agreement. After the receipt of said payment by the County, the City shall have no other obligation regarding the portions of the Project that are within unincorporated Madison County.
- 4) The City grants the County full use and access to all rights of way (ROW) within its city limits necessary for the completion of the Project.
