## **MODIFICATION NO. 1**

THIS MODIFICATION IS MADE TO THE AGREEMENT entitled "Agreement Between the City of Huntsville, Alabama and Village of Promise, Inc., as approved by Resolution No. 23-362, for the use of FY22 CDBG funds" as referenced above and is entered into on this the <u>27th</u> day of <u>July, 2023</u> by and between the City of Huntsville, Alabama and Village of Promise, Inc.

#### WITNESSETH

**WHEREAS,** Village of Promise, Inc. has indicated a need to amend the Scope of Service (Section IA, Activities) and Time of Performance (Section II);

**NOW THEREFORE**, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

Effective <u>July 1, 2022</u>, the Scope of Service (Section IA, Activities) and Time of Performance (Section II) of the Agreement is deleted and replaced with the following:

### I. SCOPE OF SERVICE

#### (A). Activities

The Subrecipient will be responsible for administering the CDBG <u>2022</u>, Family Advancement Center Program through the Family Connections Initiative in a manner satisfactory to the Grantee and consistent with any standards required as a condition of providing these funds.

# II. TIME OF PERFORMANCE

Services of the Subrecipient shall start on <u>July 1, 2022</u> and end on <u>December 31, 2023</u>. The term of this Agreement and the provisions herein shall be extended to cover any additional time period during which the Subrecipient remains in control of CDBG funds. The Subrecipient shall forfeit all funds not expended by the end of the term of this Agreement.

The Parties agree that any form of electronic signature, including but not limited to signatures via facsimile, standing, or electronic mail, may substitute for the original signature and shall have the same legal effect as the original signature.

All other terms and conditions of the Original Agreement remain unchanged and in full force and effect.
