BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, that the Mayor be, and he is hereby, authorized to enter into and agreement, between the CITY OF HUNTSVILLE, an Alabama municipal corporation, and JEFF WHITE D/B/A JEFF WHITE PHOTOGRAPHER, which said agreement is substantially in words and figures as that certain document attached hereto and identified as "Consulting Agreement between the City of Huntsville and Jeff White d/b/a Jeff White Photographer," consisting of two (2) pages and the date of March 28, 2024, appearing on the first page thereof, together with the signature of the President or President Pro Tem of the City Council, an executed copy of said document after being signed by the Mayor, shall be permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama.

CONSULTING AGREEMENT BETWEEN THE CITY OF HUNTSVILLE AND JEFF WHITE d/b/a JEFF WHITE PHOTOGRAPHER

CONSULTING AGREEMENT BETWEEN THE CITY OF HUNTSVILLE AND JEFF WHITE d/b/a JEFF WHITE PHOTOGRAPHER

THIS AGREEMENT is made and entered into on the <u>28th</u> day of <u>March</u>, 2024, by and between Jeff White d/b/a Jeff White Photographer, ("White") and the City of Huntsville, Alabama, a municipal corporation in the State of Alabama (the "City"),

WITNESSETH:

In consideration of the mutual promises and covenants herein contained, the parties do hereby agree as follows, to wit:

- 1. White shall provide professional services as a Consultant to the City Administration and shall provide professional photographic services for promotion and branding materials for digital and print media. White acknowledges that the City from time to time desires to seek copyright registration protection for certain works of authorship created by the City, and to which White may make contributions in the form of copyrightable works of authorship. White agrees to assign, and hereby does assign, to the City, all right, title, and interest including all copyright rights, in and to any works of authorship he delivers to the City under this contract. To the extent White desires the right to thereafter use said works, the City hereby provides to White a royalty-free, non-exclusive, license to subsequently use, copy, and distribute, said works.
- 2. White is hereby contracted as an independent contractor and shall have no authorization to incur any debt or obligation on behalf of the City nor shall he be entitled to any benefits of any kind while working for the City. White is not deemed an employee of the City. During the term of this agreement, White shall report to and receive task assignments from the Director of the City's Communication Office.
- 3. The term of this contract shall be for a period of one year commencing on April 1, 2024 and continuing through March 30, 2025.
- 4. This contract may be terminated by either party upon thirty (30) days written notice being provided to the other party.
- 5. The City shall pay White the rate of Twenty-five Dollars (\$25.00) per hour for work performed pursuant to this agreement. White shall invoice the City monthly for payment for services rendered pursuant to this Agreement and shall itemize the cost for each task. The City will remit payment to White in a timely manner upon its receipt of an invoice. The total amount paid to White pursuant to this agreement shall not exceed Fifteen Thousand Dollars

(\$15,000.00). Additional assignments above and beyond the scope of this contract will be priced separately pursuant to agreement between the parties. Because White shall act in the capacity of an independent contractor, the City will not withhold from payments to be made to him any sums for income tax, unemployment insurance, social security, or any other tax or withholding. White expressly acknowledges and agrees that he is solely responsible for the payment of all income and other taxes for sums received by him pursuant to this Agreement.

- 6. White shall be responsible for maintaining automobile liability insurance on any vehicle owned or leased by him and used while performing services for the City with minimum limits of \$100,000 for personal injury; \$100,000 property damage; and \$300,000 per occurrence. The said insurance shall be written so as to cover White when he is performing the services set forth in this agreement.
- 7. White acknowledges that confidential information in the way of financial practices, internal activities and operations, may be made available to him in connection with her work pursuant to this agreement. White agrees not to disclose the confidential information to any third party at any time following execution of this agreement. This clause shall survive the termination of this agreement.
 - 8. This agreement constitutes the entire agreement between the parties.
- 9. This agreement shall be governed by the laws of the State of Alabama. Venue of any action to enforce the terms of this agreement shall be in the Circuit Court of Madison County, Alabama or the United States District Court for the Northern District of Alabama, Northeastern Division.
- 10. White shall be responsible for providing all services, supplies, instruments of service, and facilities necessary for performing the task assignments and shall be compensated as set forth herein.
