ORDINANCE NO. 23 – ____

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, that Budget Ordinance No. 22-736, adopted and approved on September 22, 2022, is hereby amended as follows:

In the GENERAL FUND:

Increase the Finance department personnel appropriation and decrease the Clerk Treasurer department personnel appropriation by \$480,656.42 for the change in authorized strength per Resolution 23-106 adopted on February 9, 2023.

In the 1% LODGING TAX 2013 FUND:

Authorize the Huntsville/Madison County Convention and Visitors Bureau to commit funds in excess of \$100,000.00 in accordance with Ordinance No. 13-915 (2013 Lodgings Tax Advisory Committee) for support of the following events:

- \$145,000.00 (\$70K year one/\$75K year two) for the 2024 and 2025 Alabama League of Municipalities annual conventions.
- \$214,000.00 for the 2024 or 2025 National Tour Association Travel Exchange conference.
- \$350,000.00 for the 2025 Major League Fishing Redcrest Championship event.
- \$250,000.00 (5 years/\$50K per year) for the 2022-2026 Exposure Youth Camp events.
- \$181,000.00 for the 2026 Union Cycliste Internationale Paracycling World Championship event.
- \$150,000.00 (2 years/\$75K per year) for the Sports Network LLC Military Hoops Salute to Service.
