**WHEREAS**, the City of Huntsville, Alabama previously entered into an agreement between Crisis Services of North Alabama, Inc., for services pursuant to a grant award for FY2020 Emergency Solutions Grant Coronavirus (ESG-CV) Program funds known as Grant No. HESG-CV-20-002 0005; and,

**WHEREAS**, Crisis Services of North Alabama, Inc. requested to amend Section IV (Time of Performance) and Section V (Compensation and Method of Payment) of their agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, that the Mayor of the City of Huntsville is hereby authorized, requested and directed to execute “Modification No. 1 to the Agreement between the City of Huntsville, Alabama and Crisis Services of North Alabama, Inc. for the use of ESG-CV funds,” consisting of two (2) pages, and the date of April 13, 2023, appearing on the margin of the first page, together with the signature of the President or President Pro Tem of the City Council, an executed copy of said document being permanently kept on file in the Office of the City Clerk of the City of Huntsville, Alabama.

**Modification No. 1 to the Agreement Between the City of Huntsville, Alabama and Crisis Services of North Alabama, Inc. for the use of ESG-CV funds.**

**MODIFICATION NO. 1**

**THIS MODIFICATION NO. 1 IS MADE TO THE AGREEMENT** entitled “Agreement Between the City of Huntsville, Alabama and Crisis Services of North Alabama, Inc., as approved by Resolution No. 21-512,” as referenced above and is entered into on this the 13<sup>th</sup> day of April, 2023 by and between the City of Huntsville, Alabama (City) and Crisis Services of North Alabama, Inc. (Agency) for the use of ESG-CV funds.

**WITNESSETH**

**WHEREAS**, the Agency has indicated a need to amend their Time of Performance (Section IV) and Compensation and Method of Payment (Section V);

**NOW THEREFORE**, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

Effective April 13, 2023, the Time of Performance (Section IV) and Compensation and Method of Payment (Section V) of the Agreement is deleted and replaced with the following:

**IV. TIME OF PERFORMANCE**

Services of the Subrecipient shall start on the February 16, 2021 and end on the August 5, 2023. The term of this Agreement and the provisions herein shall be extended to cover any additional time period during which the Subrecipient remains in control of ESG-CV funds. The Subrecipient shall forfeit all funds not expended by the end of the term of this Agreement.


