ORDINANCE NO. 23-____

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting the vacation of a utility and drainage easement; that the applicants have represented to the City of Huntsville that Wesley B. Crunkleton and Margaret Moore Crunkleton, are the owners of the property across which said easement lies; that said easement, or the portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

Legal Description



THENCE, FROM THE POINT OF BEGINNING, NORTH 81 DEGREES 22 MINUTES 18 SECONDS EAST, 90.92 FEET TO A POINT; THENCE SOUTH 14 DEGREES 35 MINUTES 11 SECONDS EAST, 22.11 FEET TO A POINT; THENCE SOUTH 86 DEGREES 26 MINUTES 21 SECONDS WEST, 92.12 FEET TO A POINT; THENCE NORTH 14 DEGREES 37 MINUTES 19 SECONDS WEST, 13.93 FEET TO THE POINT OF BEGINNING.
