2. . Successors and Assigns. This Change Order shall inure to the benefit of and be binding on each of the Parties and each of their respective [permitted] successors and [permitted] assigns
3. This Change Order may be executed in counterparts, each of which is deemed an original, but all of which constitutes one and the same agreement. [Delivery of an executed counterpart of this Change Order electronically or by facsimile shall be as effective as delivery of an original signed counterpart of this Change Order.]
4. Entire Agreement. This Change Order, the Agreement and SOW constitute the sole and entire agreement of the Parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter
5. Limited Effect. Except as modified by this and any previously issued Change Order, all other terms and conditions of the Agreement remain in full force and effect. This Change Order is executed by each of the Parties' duly authorized representatives.
