ORDINANCE NO. 26-

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, that Ordinance No. 89-79, as amended, entitled the City of Huntsville Classification and Salary Plan, be and the same is hereby further amended as follows:

Section 1. The position of Real Estate Specialist I, classified at a salary grade 9, is hereby renamed Property Specialist I, classified at a salary grade 9.

Section 2. The position of Sanitation Accounts Coordinator is hereby created and classified at a salary grade 12.

Section 3. The position of Security Officer Supervisor, classified at a salary grade 8, is hereby reclassified at a salary grade 10.

Section 4. The position of Herbicide Spray Technician, classified at a salary grade 11, is hereby reclassified at a salary grade 12.

Section 5. The position of Assistant Fire Marshal II is hereby created and classified at a salary grade 16.

Section 6. In all other respects, Ordinance No. 89-79, as amended, shall remain in full force and effect.
