**SPECIAL EMPLOYEE AGREEMENT

**SPECIAL EMPLOYEE AGREEMENT BETWEEN
THE CITY OF HUNTSVILLE AND RONALD FINLEY**

THIS AGREEMENT is made and entered into on the 28th day of May, 2026, by and between Ronald Finley, an individual, (“Finley”) and the City of Huntsville, Alabama, a municipal corporation in the State of Alabama (“City”),

WITNESSETH:

In consideration of the mutual promises and covenants herein contained, the parties do hereby agree as follows, to wit:

1. Finley shall be employed by the City of Huntsville as Sewer Maintenance employee and shall be classified as a “Special” employee under the City’s Personnel Policies and Procedures Manual.
2. The term of this contract shall be for a period of one year commencing on June 1, 2026.
3. This contract may be terminated by either party upon thirty (30) days written notice being provided to the other party.
4. Except as specified herein, Finley shall be subject to all Policies applicable to part-time employees of the City of Huntsville.
5. During the term of this contract, Finley shall perform the duties and responsibilities of Sewer Maintenance special employee and shall be under the direct supervision of the Director of Water Pollution Control. Duties of the position of Sewer Maintenance special employee shall include leading and overseeing the work of other employees in demolitions, construction, maintenance, landscape, and solid waste collection. Finley shall also be responsible for automotive maintenance and shall operate a variety of heavy equipment used in construction maintenance, waste collection, and repair.

6. Finley acknowledges that confidential information may be made available to him in connection with his work pursuant to this agreement. Finley agrees not to disclose the confidential information to any third party at any time following execution of this agreement. This clause shall survive the termination of this Agreement.
7. In consideration of the services rendered hereunder, the City shall pay Finley at the rate of \$42.73 per hour not to exceed 18 hours per week with the total sum Not to Exceed FORTY THOUSANDAND NO/100 DOLLARS (\$40,000) per year which shall be paid bi-weekly in accordance with the City's regular payroll processing system. During the term of this agreement, Finley shall not receive any cost of living adjustment approved by the City Council for all other employees of the City. In addition, Finley shall not receive any benefits available to any employee of the City except those benefits he receives as a result of being retired from regular employment with the City. Finley shall have no authorization to incur any debt or obligation on behalf of the City.
8. This agreement constitutes the entire agreement between the parties.
